

**ORDINANCE NO. 16-859**

**AN ORDINANCE TO AMEND TITLE 14, GOODLETTSVILLE MUNICIPAL CODE BY AMENDING THE ZONING ORDINANCE TO EXPAND THE I-65 AT US HWY 31W INTERSTATE SIGN DISTRICT MAP TO INCLUDE A CERTAIN PARCEL ON US HWY 31W**

**WHEREAS**, the need to expand the area of the I-65 at US Hwy 31W Interstate Sign Zone District Map to include an additional property on US Hwy 31W adjacent to I-65 and within the City's Interchange Overlay District in order to provide directional assistance provided by the Interstate Sign Zone District zoning ordinance section has been discussed by the Planning Commission at their regular meeting of February 1, 2016 and;

**WHEREAS**, The Goodlettsville Planning Commission has reviewed and discussed this proposed amendment and unanimously voted to recommend its passage to the Board of Commissioners.


**NOW, THEREFORE, BE IT ORDAINED AND IT IS HEREBY ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF GOODLETTSVILLE, TENNESSEE, AS FOLLOWS:**

**SECTION 1.** The I-65 at US Hwy 31W Interchange Zone District Map attached with this ordinance as "EXHIBIT A" is amended to include the expansion area listed on the attached map. The area attached with this ordinance as "EXHIBIT A" contains the property referenced as Sumner County Tax Map 141 Parcel 50.00 and includes the expansion of 299' feet along the US Hwy 31W property boundary and 367' feet along the I-65 property boundary.

**SECTION 2.** That the Commissioners of the City of Goodlettsville, Tennessee, hereby certify that this Ordinance has been submitted to the Planning Commission of the City of Goodlettsville for a recommendation, and a notice of hearing thereon has been ordered after at least fifteen (15) days' notice of the time and place of said meeting has been published in a newspaper circulated in the City of Goodlettsville, Tennessee. This Ordinance shall take effect fifteen (15) days from the date of its final passage, the public welfare demanding it.


**SECTION 3.** If any section, clause, provision, or portion of this Ordinance is for any reason declared invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect any other section, clause, provision, or portion, of this Ordinance which is not itself invalid or unconstitutional.

**SECTION 4.** In case of conflict between this Ordinance or any part thereof and the whole or part of any existing or future Ordinance of the City of Goodlettsville, the most restrictive shall in all cases apply.
